PLEASE TAKE NOTICE that any qualified elector of the County of Eaton, Michigan, who is not already registered, may register to vote online at www.mi.gov/vote, at the office of the Township or City Clerk; the office of the County Clerk; a Secretary of State branch office, or other designated state agency. Voters who are already registered may update their registration at www.expressSOS.com.

The last day for registering online, at the County Clerk’s office or at a Secretary of State office will be **Monday, February 12, 2024.**

After this date, anyone who qualifies as an elector may register to vote in person at their local clerk’s office with proof of residency (MCL 168.492):

Monday, February 26, 2024 at 4:00 p.m. is the deadline to request an absentee ballot except for those who register to vote on Election Day. Ballots issued on Monday, February 26, 2024 must be requested and voted in person at the township or city office, locations referenced in the above table.

Those registering to vote on Election Day, Tuesday, February 27, 2024 are eligible to receive an absent voter ballot at the township or city clerk’s office, locations referenced in the above table.
